

How to Link PAN Card with Aadhaar Number

Aadhaar is a 12-digit unique identification number issued by the Indian government to its citizens, while Permanent Account Number (PAN) is a 10-digit alphanumeric number issued by the Income Tax department to individuals and entities for tax purposes.

The Indian government has mandated that all PAN holders must link their Aadhaar number to their PAN card. The deadline to link Aadhaar with PAN has been extended several times in the past, and the latest deadline is March 31, 2023.

If an individual fails to link their Aadhaar with their PAN by the deadline, their PAN card will become inoperative from April 1, 2023. This means that the individual will not be able to use their PAN card for any financial transactions that require it, such as opening a bank account, filing income tax returns, or making investments.

Last date and fee for linking PAN-Aadhaar:

Here are some key points to keep in mind regarding the deadline to link PAN with Aadhaar and the associated fee:

- The original deadline to link PAN with Aadhaar was 31st March 2022.
 - The Central Board of Direct Taxes (CBDT) extended this deadline to 31st March 2023
 - This means that individuals have until 31st March 2023 to link their PAN with Aadhaar.
 - However, to initiate the linking process, individuals are required to pay a fee of Rs 1,000.
 - This fee is applicable only if the linking is done after the original deadline of 31st March 2022.
 - If the linking is done before the original deadline, there is no fee charged.
- How to pay fee to Link PAN with Aadhaar To pay the fee to link PAN with Aadhaar, you can follow these steps:**
- Visit the official website of the Income Tax Department.
 - Click on the 'Link Aadhaar' option under the 'Quick Links' section.

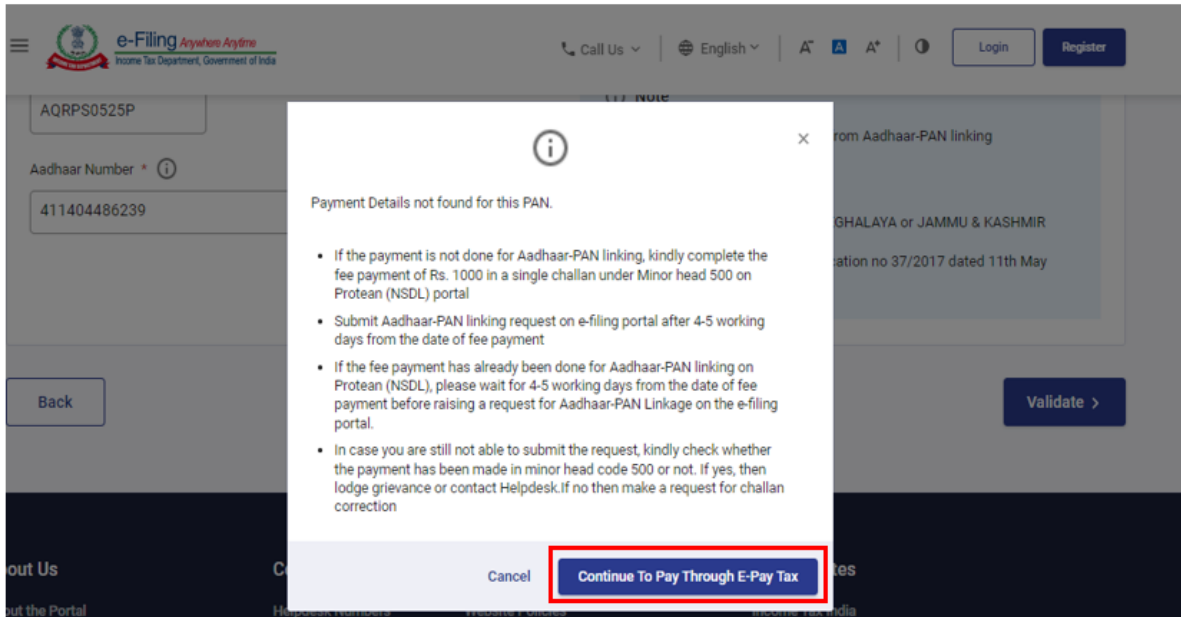

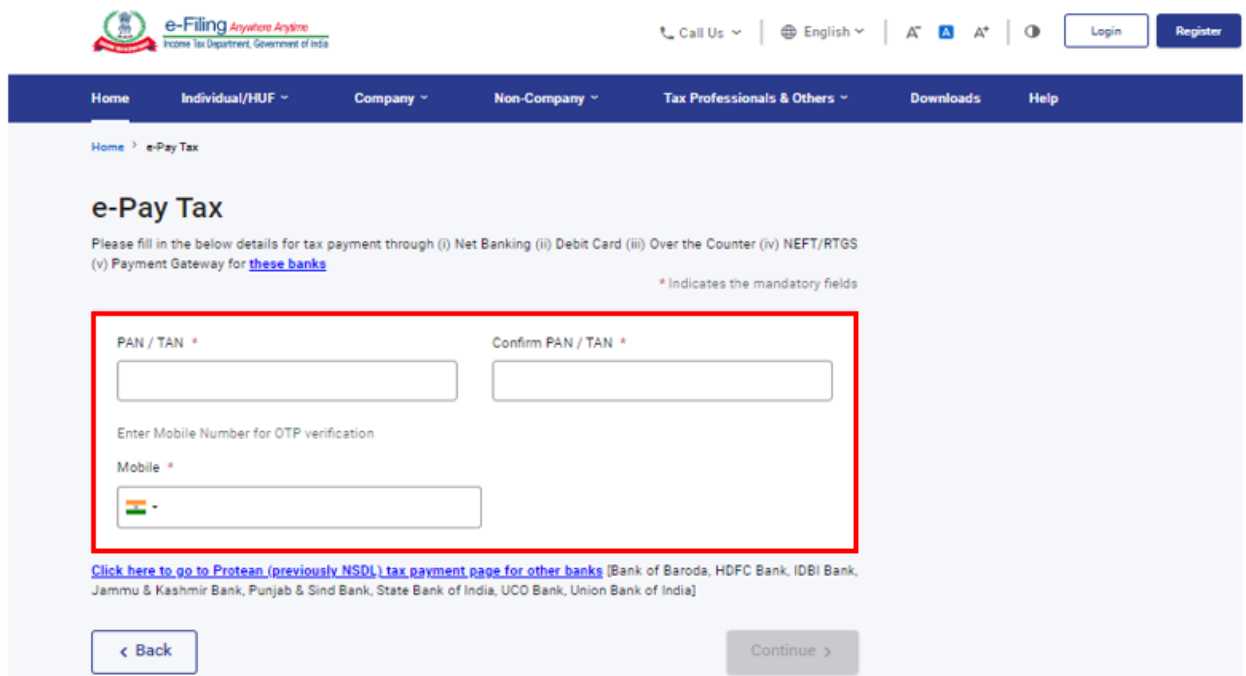
